

## Now Gaushal at Raj Bhavan in Gujarat

In Gujarat Raj Bhavan - Gandhinagar while entering the sweet bells of a small bell are heard in the ears, as well as the sound of the calf calf. The visitor here may feel that he has come to a place where he does not belong to the government building, but to a ritualistic tradition, following political protocol. But things are different.

Following the Vedic tradition, the Governor of Gujarat, Acharya Devvrat, is preparing a Gaushala at Rajbhavan, where Gir is raising cattle and his calf. The Governor visits the Gaushala regularly. Since he has a keen interest and knowledge in cattle herding, he is giving guidance to the guardian of the cow and his calf. This cow's calf is full and its milk is consumed in the Rajbhavan only after its mother is weaned. The number of cows will be increased in the coming



time. After the removal of milk from the use of Rajbhavan, everything that will grow will be distributed among the employees of the milk. Not long ago, the Governor called for this cow from Gir and they are constantly spreading propaganda for the improvement of the breed of Gir cows and Desi cows. The cows are weeded daily by the full organic method.

When Acharya Devvrat was the Governor of Himachal Pradesh, he gave the slogan 'One house, one cow'. He says that wherever there is, a gum should be added to it with a gum. It should be used for composting. It will also provide good fertilizer to the farmers. Farmers will be rid of pesticides and precious fertilizers, which also causes illnesses. I am also a farmer and I have a gurukul in

Kurukshetra, where there are 300 cows. Fertilizers are prepared from their urine. He had a Sindhi cow in the Himachal Raj Bhavan. He even put up pillows for the cow's comfort. They also have warm clothes for them in the cold. Himachal Rajbhavan never bought milk, yogurt, butter and garlic from the market during his tenure. A special person was also appointed in the Raj Bhavan to look after the cows.

The cow has been a symbol of wealth in India since ancient times. The cow was possibly revered because humans are relied heavily on it for dairy products and for tilling the fields, and on cow dung as a source of fuel and fertilizer. Reverence for cows is in the major texts of the Vedic religion. Mahatma Gandhi said that "I worship it and I

shall defend its worship against the whole world," Gandhi regarded Cow better than the earthly mother, and called her "the mother to millions of Indian mankind." Cow-based farming has been the backbone of our agriculture for centuries. The initiative taken Gujarat Governor reveals the fact that the cow is very much attached to the sentiment and the cultural traditions of the people. It is to be remembered that cow is the back-bone of Indian economy. India was golden bird until cow was base of agriculture. It is nice that our government runs several goshalas, shelters for old cattle, across the country, but these are too few and are not governed by serious norms.
